Payment Information: Please use the enclosed envelope to mail your payment to Hillsdale Board of Public Utilities, 45 Monroe St., Hillsdale, Michigan 49242. Payments can also be made at our office or dropped in our 24 hour deposit box at 45 Monroe Street. Payments can also be made at Nash Drugs located downtown Hillsdale.

For our customer's convenience we also offer a budget billing program and an automatic bill payment program. For more information on either of these programs, please call our office.

Business Hours: Normal business hours are Monday through Friday, 8:00 A.M. to 5:00 P.M.. Emergency service is available 24 hours a day, 7 days a week. To report a problem call 437-3387, and carefully follow the instructions.

Electric Service Rates: Along with a meter charge each month. Usage is measured and billed monthly.

Water Service Rates: Along with a meter charge each month, usage is measured and billed per thousand gallons consumed.

Sewer Service Rates: Along with a meter charge each month, usage is measured and billed per thousand gallons based on water readings.

Meter charges for all utilities are prorated for partial month's usage. A copy of all utility rates, rules and regulations are available, upon request, at the office.

Late Charges: When a payment is not received by the stated due date on the bill or within the two day grace period, a reminder notice shall be mailed to the customer and a late charge assessed against the account. Approximately 10 calendar days after the reminder letter, if payment is still not received, a final notice will be mailed to the customer which will indicate a "pay by" date for payment to be received by in order to avoid disconnection. The final notice will give a minimum of five calendar days to pay the amount due. If payment has not been made in the time allowed from the final notice, disconnection will take place during normal working hours. Any additional fees will be assessed in accordance with the rules and regulations.
