Director's Report

AMP report update

<u>Items:</u>

1. <u>2016 Vacuum Type Catch Basin/Hydro-Excavator with a High Pressure Jet Rodder (Vactor Truck).</u>

The current budget includes funds for the replacement of a 1999 Vactor 2110 Jet Rodder. The Vactor was put out for bids to 3 vendors; Jack Doheny Supplies, Coe Equipment and Vactor Manufacturing. We had one (1) bid supplied to the Utility: Jack Doheny Supplies...\$383,282.00.

The budget allows for \$285,000 for FYE 2017 in Capital Projects.

Recommendation: With the bids coming in higher than anticipated, the current status of our water/sewer fund and the deteriorating operating condition of the 1999 Vactor, I am recommending that we purchase the purposed 2016 Vacuum Type Catch Basin Cleaner/Hydro-Excavator with a High pressure Jet Rodder at a cost of \$80,855.63 per year for 5 years. In this cost is an interest rate of 2.74%.

Last year it was decided to sell the field equipment utilized for putting the sludge into the ground at certain chosen fields. This has been accomplished for the most part, with the exception being the 2010 Field Gymmy. To date we have received little interest but we were able to secure several bids in the \$50,000 to \$60,000 range. At that time we felt this was too far under value for the unit and passed on those offers.

After a year of sitting at the WWTP, we have recently secured an offer of \$60,000.

Recommendation: It is Staff's recommendation to accept the offer of \$60,000 from Terry Wickenhiser for the 2010 Field Gymmy.
