HIGHLY ANTICIPATED REHABILITATION OF HISTORIC KEEFER HOUSE HOTEL UNDERWAY



On August 16th, CL Real Estate Development (CLRED) broke ground on the long-awaited development of the Keefer House Hotel. Contractors arrived on site on Monday, August 16th, 2021, and crews began interior demolition on August 23rd, carefully uncovering and preserving layers of our long-forgotten Hillsdale history.

In September, CLRED hosted a groundbreaking ceremony to officially mark the occasion with speeches from City Manager David Mackie, CEO of CL Enterprises, Peter Limberger, and keynote speaker, the Principal Architect, Gary Anderson. Progress continues with interior demolition to prepare the site for the next phase of the project.

CLRED intends to restore the Keefer House Hotel to its original splendor with particular respect to Hillsdale's industrial history. Restoration features 34 unique guest rooms with a restaurant, a bar, spaces for private events, and retail space. Guests to the hotel will be able to experience the town hotel's iconic mosaic floors, original tin ceiling, and restored mill work as the hotel guests once did. CL Real Estate Development is honored to revitalize this prominent part of Hillsdale's history and breathe new life into the hotel's block of our downtown area.

The project is expected to generate a total capital investment of \$12.3 million and create 50 full time equivalent jobs.

On October 13th, the Keefer House Hotel received a visit from Michigan Governor Gretchen Whitmer, highlighting her MI New Economy plan.

HILLSDALE COMMUNITY LIBRARY RECEIVES GRANT



The Hillsdale Community Library received a \$15,000 grant from the Michigan Humanities Organizations Pandemic Emergency (MI H.O.P.E) - a grant program designed to assist Michigan cultural and community organizations impacted by the COVID-19 pandemic.

The Library will be using these acquired funds to expand its existing children's programs. Such after-school programs include: Lego Club, Science Club, and Arts and Crafts Club. Youth programs are open to <u>ALL</u> area youth and do <u>not</u> require a library card or registration to participate.
